

# Satisfactory Academic Progress (SAP) Policy

## Financial Aid Recipients for 2017-2018

### Undergraduate Students

#### 1. Cumulative GPA:

The cumulative number of credits attempted in the undergraduate schools of the University include those credits attempted as of the census date (5 calendar days after the last day to drop a course (Drop/Add). Multiple attempts of the same course will be counted (each attempt) for financial aid purposes.

Effective with the 2017-2018 academic year: Students must maintain a minimum cumulative GPA of 2.0 in order to remain in good standing for the receipt of financial aid funding.

#### 2. Cumulative Hours Earned:

A student must pass (earn) at least 67% of their credits attempted (excluding non-credit courses and pass/fail courses).

#### 3. Maximum Time Frame:

Undergraduate students must complete their degree requirements within 150% of the published length of their academic program to remain eligible for federal financial aid. This is the maximum allowable time for receipt of financial aid regardless of whether the student did or did not receive financial aid during any period of his/her enrollment. In addition, students will be allowed to receive **institutional financial aid** for a maximum of 150 % of their published program length.

### Graduate Students

**Master of Business Administration (MBA), Master of Accounting (MAC), Master of Science in Sport Administration (MASM), Doctor of Education in Educational Leadership (EDD/EDS), Master of Arts in Education (MAED), Master of Arts in Teaching (MAT)**

#### 1. Cumulative GPA:

A student must achieve and maintain a Cumulative Grade Point Average of 3.0.

#### 2. Cumulative Hours Earned:

A student must pass (earn) at least 67% of their credits attempted (excluding non-credit courses and pass/fail courses).

#### 3. Maximum Time Frame:

All students must complete their degree requirements within 150% of the published length of their academic program, regardless of whether the student did or did not receive financial aid during any prior period of his/her enrollment.

### Health Professional Graduate Students

**Doctor of Pharmacy (PharmD), Master of Physician Assistant Studies (MPAS), Doctor of Physical Therapy (DPT)**

#### 1. Cumulative GPA:

**PharmD** students must achieve and maintain a Cumulative Grade Point Average of 2.0.

**MPAS** students must achieve and maintain a Cumulative Grade Point Average of 3.0. They must also maintain a semester GPA of 3.0

**DPT** students must achieve and maintain a Cumulative Grade Point Average of 2.7.

#### 2. Cumulative Hours Earned:

A student must pass (earn) at least 67% of their credits attempted (excluding non-credit courses and pass/fail courses).

#### 3. Maximum Time Frame:

All students must complete their degree requirements within 150% of the published length of their academic program, regardless of whether the student did or did not receive financial aid during any prior period of his/her enrollment.
